

Barometer Brand Standard Categories & Definitions

At Barometer, we operationalize and expand upon consensus definitions of the GARM categories as presented in the *GARM Brand Safety Floor & Suitability Framework*. We recognize that podcasts are a unique medium with long, conversational content, which is difficult for humans to parse consistently. As such, our key contribution is to transparently define how to evaluate the risk level of each GARM component specifically in podcasts. Furthermore, our solutions extend far beyond the limited set of GARM categories to meet advertisers and publishers with the nuance required to overcome today's over-blocking challenges.

To this end, we have developed a rich database of examples of each of these components, at each level of risk, across all of the top shows. We also have developed sophisticated tonal analysis tools that allow us to fingerprint the different tones present in the podcasts, in order to measure for the differences between glamorizing content (high risk). dramatizing content (medium risk) and educational content (low risk)...

Finally, we have intelligent topic modeling about a large set of debated sensitive social issues (listed here) based on signals from both podcasts as well as news content. This allows us to truly contextualize the podcast contents in broader culture, taking into account everything from the subject matter to the posturing between the podcast host and guest(s).

Now we will discuss each component of the Barometer Brand Standard Framework in detail. We will provide the GARM definitions for each risk level (if applicable)I, the contextualized definition for podcasts, and the range of output scores operationalizing each level of risk.

GARM 1: Adult/Explicit Content

We measure for Adult/Explicit content using a two step process:

- 1. First, we characterize whether there is any adult content at all in a particular piece of content. If there is no adult content detected, the score "no risk" is assigned.
- 2. If adult content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

Arms & Ammunition

We measure for Arms and Ammunition content using a two step process:

- First, we characterize whether there is any arms & ammunition related material at all in a
 particular piece of content. If there is no content related to arms and ammunition detected, the
 score "no risk" is assigned.
- 2. If arms and ammunition related content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in

combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

Crime & Harmful acts to individuals and Society, Human Right Violations

We measure for crime, harmful acts and human rights violations related content using a two step process:

- First, we characterize whether there is any crime and harmful acts related discussion at all in a
 particular piece of content. If there is no content related to arms and ammunition detected, the
 score "no risk" is assigned. We developed our model of crime and harmful acts related topics
 through detailed research of government websites and international guidance including the UN
 Declaration of Human Rights.
- 2. If crime related content is present, we must determine the risk level. We then use the GARM definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

Death, Injury or Military Conflict

We measure for Death, Injury or Military Conflict related content using a two step process:

- 1. First, we characterize whether there is any mention of death, injury, or military conflict at all in a particular piece of content. If there is no content related to arms and ammunition detected, the score "no risk" is assigned.
- 2. If death, injury and military conflict related content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

Online Piracy and Spam or Harmful Content

We combine the measurement of Online Piracy and Spam content using a single two step process. We chose to combine them because there were no significant distinctions between the topics associated with Online Piracy and Spam or Harmful Content.

- First, we characterize whether there is any discussion of topics related to Online Piracy, Spam or harmful content at all in a particular piece of content. If there is no such content detected, the score "no risk" is assigned.
- 2. If Online Piracy, Spam or harmful content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

Hate speech & acts of aggression

We measure for hate speech & acts of aggression related content using a two step process:

- 1. First, we characterize whether there is any mention of hate speech and/or acts of aggression at all in a particular piece of content. If there is no content related to hate speech and/or acts of aggression detected, the score "no risk" is assigned.
- 2. If hate speech or acts of aggression related content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

We measure for profanity and obscenity in a two-step process:

- First, we characterize whether there is any profanity or obscene content at all in a particular
 piece of content. If there is no profane or obscene content detected, the score "no risk" is
 assigned.
- 2. If obscene and profane content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

- 1. First, we characterize whether there is any content relating to drugs or alcohol at all in a particular piece of content. If there is no such content detected, the score "no risk" is assigned.
- 2. If drug or alcohol related content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

We measure for terrorism related content using a two step process:

- 1. First, we characterize whether there is any mention of terrorism at all in a particular piece of content. If there is no content related to terrorism detected, the score "no risk" is assigned.
- 2. If terrorism related content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are

high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

 piece of content. If there is no content related to natural disasters detected, the score "no risk"
 is assigned.
- 2. If discussion of natural disasters or related content is present, we must determine the risk level. We then use the Barometer definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

- 2. If discussion of gambling or related content is present, we must determine the risk level. We then use the definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

We measure for occult related content using a two step process:

- 1. First, we characterize whether there is any mention of the occult at all in a particular piece of content. If there is no content related to the occult detected, the score "no risk" is assigned.
- 2. If discussion of the occult or related content is present, we must determine the risk level. We then use the definition contextualized for podcasts to classify whether the issues discussed are high, medium or low risk. Finally, we look at the tone. This final step is used, in combination with the topic classification, to ultimately provide a score of high, medium, or low risk.

Debated Sensitive Social issues

We have a three-phased approach identifying debated sensitive social issues (DSSI) in podcast content. We acknowledge that the DSSI we are measuring are primarily relevant to the English speakers in the United States. In the first phase, available now, we are looking for the presence of the DSSI listed here. Similarly to the other components, we first identified transcripts that mentioned debated sensitive social issues, and then did an analysis to understand the level of risk based on the following definitions:

This initial set of DSSI was selected after synthesizing the most polarizing DSSI in the USA based on research from the Pew Charitable Trust (cite). In the next phase, we will be dynamically expanding the list of issues we are listening for by incorporating a live-news-reader responsible for capturing new or trending topics and relating them to the existing topic models. In the final phase, we will implement a time variable that will allow us to identify debated sensitive social issues as they enter and leave the discourse, and focus on the most current issues at hand.
